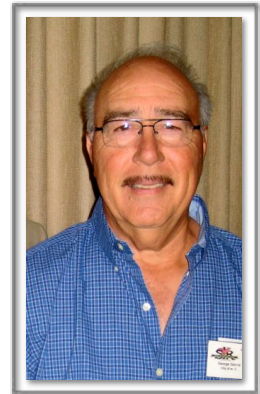

Know Your Fellow Sir- Jack Barnaba & Marvin



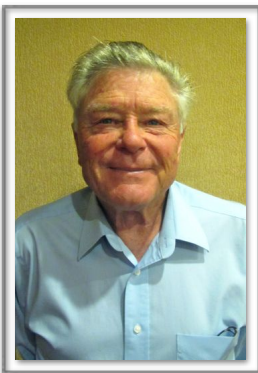
Jack Barnaba Hi fellow SIRs. I was born in Jersey City in December, 1947. While in

first grade my parents bought a home in the small town of Waldwick, NJ where my younger brother Jim, sister Deb and I all grew up through high school. It was a nice time to be in a small town. I then attended Lehigh University in Bethlehem, PA (this was the farthest I had ever been from home, 100 miles). I graduated with a BS in Industrial Engineering in 1970. My wife, Michelle, and I married that year and moved to Glen Rock, NJ. I went to work as an IE for Colgate Palmolive at their manufacturing plant in Jersey City on the Hudson River. This was directly across the river from the construction of the World Trade Center towers. In 1975, we bought our first home in Mahwah, NJ and started a family with son Keith, closely followed by daughter Tracy.

We transferred with CP from the Home Office in NYC to the Berkeley plant in 1978. We expected to spend a couple of years here and then transfer back to the east coast. Instead, in 1980 Clorox came along and we became northern Californians. We have lived in Concord since 1978 except for two years (85-86). We spent that time in Fort Atkinson, WI making Moore's frozen onion rings and appetizers. It was a fun business for engineers. Clorox was a terrific place to work. I was there for 27 years and most of the nine positions I had were brand new when I moved into them. After a career that had me logging over two million miles in the air, I retired in 2007 as VP of Applied Technology.

Our kids are married and live locally. We have two grandchildren, JP who is five and Sydney who is two plus. We are fortunate that we can spend lots of time with them. It certainly keeps us young.

I ran into **Bill Stephenson**, who I had known for many years, and Jim Randall at jury duty in 2007. They told me about the SIRs and invited me to lunch. I decided to give it a try. Know Your Sir - Marvin Terrell

Born **Marvin James Terrell**, February 24, 1940, in Littlefield, Texas.

With three kids in tow my mom and dad moved to San Francisco, California in 1942. We lived in the Bernal Heights area until we moved to Concord in the summer of 1949. While in San Francisco my mom had three more kids. Now there were three of us born in Texas and three born in California, three boys and three girls.

I graduated from Mount Diablo High School in 1957, and soon went to work at the Beacon gas station on Galindo and Cowell in Concord. Sometime during 1959 a young lady with her girlfriends came in for gas. That was when I met Judith Ann Atwood. We were married at the St. Mary's church in Concord on August 20, 1960. Our son was born on March 7, 1964. His name is James Andrew Terrell.

I thought I would be a gas jockey, but fate stepped in and in 1961, while out of work, my dad said I should join the Carpenters Apprenticeship. I soon found out carpenter work came to me very easy.

In 1965 I became the first apprentice carpenter in our area to be in the Northern California Apprenticeship Contest. While in Monterey I was asked to become a member of the local union Executive Board. In 1968 I was elected as trustee and served until 1981. During that time I served as interim president, vice president, and recording secretary. I was the youngest carpenter to serve on the Executive Board. I was elected to be an assistant business representative in 1977. Again I was the youngest carpenter to serve as a representative. My boss in 1979 asked me to get involved in the politics of Contra Costa County. Like being a carpenter, this also was easy for me. In 1989 I was elected as senior business representative of the local County. One year later I oversaw the entire county. I retired from the position in 1994. I received an Associates degree from Golden Gate University in 1987. During those years I served on the Parks and Recreation Commission of Concord from 1981 until 1989.

In 1984 I was sponsored to run with the Olympic torch through Walnut Creek, a total of five miles. My sponsor was Senator Alan Cranston. After retiring in 1994, my older brother and I hiked up Mount Whitney to 14,495 feet altitude. He was 60, I was 54.

I served on the advisory board to the city of Concord from 1987-1988 and recommended the rezoning of downtown Concord. In 1989 I was appointed to the Contra Costa County planning commission. I have served as Chair and Vice Chair. In October of 2011 I was honored to be named Commissioner of the Year by the California County Planning Commissioner's Association.

I have served as an advisor to the Mount Diablo District School Board concerning excess land from 1990 -1991. I was a panelist for Leadership Contra Costa from 2005 to 2008. I belonged to the Sheriffs Posse from 1987 to 1994. I was a member of the Contra Costa Food Bank from 1992 to 1993. I was appointed to the Northern California Carpenters trust fund from 1990 to 1994.

I became the Golf Chair for SIR Branch 19 in 2008. I am still serving you as the chairman. In 2010 I was elected as a Board member of Sir Branch 19.

New Member Recruitment is Successful Branches are Improving

Our goal was to recruit 1,900 new members in 2011. Branch leaders exceeded this goal by recruiting and inducting 2,100 new members. This is an outstanding accomplishment which puts to rest the idea that newly retired men are not joiners. They will join SIR branches that are appealing. But this successful year is only a start.

The SIR organization fell on hard times in recent years. Overall membership declined from about 32,000 members in 1990 to about 18,000 now. 44 branches failed and closed in the last 12 years. We know why this happened. We lost our focus on maintaining a good balance of newer and older members in our branches. We did not recruit enough new members annually to maintain a good proportion of newer members and our branches became less appealing and lost members.

Our challenge now is to restore this balance. We have found that recruiting new members every year at the annual rate of at least 10% of membership is needed. We met and exceeded this goal in 2011. So when Branch leaders remind you to sponsor a new member, please respond by inviting your retired friends and acquaintances to join. Each successive year this goal is met the proportion of newer members in your branch will increase. Over time balance will be restored and your improved branch will be there for you and for those who come after you.
